

The Privacy Policy

This Privacy Policy and Cookie Policy defines the principles of proceeding with personal data and using cookie files as well as other technologies on the www.thebestofmontenegro.com website.

Definitions

For the purpose of this privacy policy, the following definitions apply to the terms used herein:

Administrator – Gray International sp d.o.o. Bulevar Revolucije 80, 81000 Podgorica, Montenegro.

Website – website available at www.thebestofmontenegro.com

User – any entity using the Website.

Personal data

The User may provide their personal data to the Administrator via forms available on the Website, such as the newsletter subscription form or contact form.

The Administrator is the administrator of the User's personal data.

Data provided to the Administrator through the newsletter subscription form is processed for the purpose of sending the newsletter to the User.

The Administrator will guarantee confidentiality of any personal data provided to it. Providing the data is voluntary, but necessary in order for the User to take action for which a given form is intended.

The Administrator will not disclose data provided to it to any third parties.

Personal data is collected with due diligence and it is properly secured against access to it by people unauthorised.

The User is entitled to the following rights:

- * the right to request access to their personal data, clarify it, delete or restrict its processing,
- * the right to express an objection to processing,
- * the right to data portability,
- * the right to revoke consent to process personal data for a specific purpose if the User has already granted such a consent,
- * the right to submit a complaint to a supervisory authority in relation to the processing of personal data by the Administrator.

The Administrator hereby informs the User that they entrust the processing of personal data to the following third parties:

mailchimp.com in order to use the mailing system for sending out mailing,

Cookies

The Administrator uses cookies, i.e. small pieces of text information stored on the User's end device (e.g. computer, tablet, smartphone). Cookies can be read by the Administrator's IT system.

The Administrator stores cookies on the User's end device, and then accesses the information contained therein for statistical and marketing purposes, and to ensure proper functioning of the Website.

The Administrator hereby informs the User that the web browser can be configured in a way that prevents cookies from being stored on the User's end device. In such a situation, the use of the Website might be more difficult for the User.

The Administrator indicates that cookies can be deleted by the User after they are saved by the Administrator using appropriate browser features, software made for this purpose, or tools available within the operating system used by the User.

Other technologies

The Administrator hereby informs the User that they apply the following technologies for tracking activities of the User on the Website:

Facebook Pixel – to manage Facebook ads and conduct remarketing activities,

Google Analytics tracking code – in order to analyse Website statistics.

Server logs

Use of the Website is associated with sending enquiries to the server on which the Website is stored.

Any enquiry sent to the server is stored in server logs.

Logs cover IP address of the User, data and time of server, information about web browser and operating system used by the User, etc.

Logs are saved and stored on a server.

Data saved in server logs is not associated with any particular people using the Website and it is not used by the Administrator for the purpose of identifying the User.

Server logs constitute solely an auxiliary material that is used for Website administration. Their content is not disclosed to any parties besides people authorised to manage the server.
